Management Discussion of Fund Performance

Investment Objectives and Strategies

The objective of the Mawer Global Small Cap Fund (the "Fund") is to invest for above average long-term returns in securities of smaller companies around the world. This is done by choosing companies that we believe will be wealth-creating in the long-term and are trading at a discount to their intrinsic value. We prefer companies with enduring competitive advantages that will allow them to earn a return greater than their cost of capital over the long-term. The Fund has a long-term buy-and-hold strategy and seeks to keep turnover low.

Risk

This Fund is suitable for investors seeking long-term growth and who have a medium-to-high tolerance for risk. General risks of investing in this Fund are outlined in the Prospectus and include the possibility of reduction in value of any given investment, liquidity risk, interest rate risk, and currency risk amongst others.

The Manager reduces the exposure to these risks by not concentrating more than 20% of the net assets of the Fund in a particular industry (i.e., sub-sector) as defined by the Global Industry Classification Standards (GICS). It is also the Manager's policy to have no more than 10% of the net assets in any one common share of a corporation, at the time of purchase. The Fund typically owns positions in global corporations with a market capitalization of \$3 billion (USD) or less at the time of purchase. It is the Manager's intention to be generally fully invested (less than 5% in cash).

The Fund was invested in 8 of the 11 Global Industry Classification (GICS) sectors as at June 30, 2022. The Fund's largest sector weightings were in Industrials (29%), Information Technology (18%) and Consumer Discretionary (15%). Combined, the weight in the three largest sectors represented 62% of the portfolio which is a decrease from 63% at the end of 2021. In aggregate, the ten largest individual holdings accounted for 29% of the portfolio which is down from 32% as of December 31, 2021.

Results of Operations

The Fund's net assets decreased 27.2% to \$3,074.0 million from \$4,221.3 million at June 30, 2022. Of this change, -\$916.7 million is attributable to investment performance and -\$230.6 million was due to net redemptions to the Fund.

The Manager assesses the fund's underlying securities for liquidity on a quarterly basis. During the period the fund has remained in compliance with National Instrument 81-102 and has maintained an illiquid concentration of less than 10% of the fund's Net Asset Value. During the period there were no notable redemptions to the fund that affected its liquidity.

Over the past 6 months, the Fund's Series A units returned -22.8% (after management fees) versus a -20.6% return for the blended benchmark which consists of the Russell Global Small Cap Index from inception to September 30, 2016 and the MSCI ACWI Small Cap (Net) Total Return Index onwards. All performance values provided are in Canadian dollar terms.

When assessing relative performance by sector, the Fund's negative relative return is attributable to both sector allocation and security selection. In sector allocation, the largest detractor was the lack of exposure to Energy which performed well over the period. In security selection, the negative security selection was driven by the Fund's Consumer Staples and Consumer Discretionary holdings, which underperformed their respective benchmark peers over the period.

When examining relative return from a geographical perspective, the Fund's underperformance is attributable to regional allocation, with security selection being a slight detractor as well. With regional allocation, the overweight to Europe ex-UK was the largest detractor as this market performed poorly over the period. In security selection, the largest detractor was Japan, followed by Europe ex-UK, as the Fund's holdings in these markets didn't perform as well as their benchmark peers.

Overall, the top contributors to the Fund's performance were CBIZ Inc, Cembra Money Bank, Heineken Malaysia Bhd, Sabre Insurance Group, and Dermapharm Holding. Conversely, De'Longhi, Atea ASA, RS Group, Softcat PLC, and On the Beach Group were the largest year-to-date detractors.

Recent Developments

As the performance of various asset classes so far this year suggests, risks are clear and present: inflation, central bank tightening, and the withdrawal of accommodative monetary policy; war and its knock-on impacts to globalization and various commodity markets; and economic growth headwinds tied to COVID-19 shocks and the impact of rising food and energy prices on consumers. Margin pressures due to rising wage and input costs are beginning to impact corporate profits and we've seen severe reactions to earnings disappointments, particularly with respect to future guidance. The European economic outlook looks particularly grim given the increasing risk of a Russian gas embargo to the European Union. The recent performance of equities, credit spreads, economically-linked commodities such as copper, and the U.S. dollar all point to an increasingly pessimistic outlook.

In managing portfolios, we often ask ourselves: are we over-exposed in any areas, and do we have appropriate mitigation strategies in place? Despite the general direction of recent trading activity, the portfolio remains tilted toward higher-quality companies with more recurring business models. This is very much intentional. Those parts of the market that have fared relatively better so far this year may also prove to be more fragile, especially if the outlook for economic growth continues to deteriorate.

Whereas the risks may appear heavily one-sided, we have been focused on ensuring that our emotions stay balanced. Our philosophy and process orient us toward businesses that are enduring, that have the ability to exercise pricing power through the value propositions they provide to their customers, and that are run by able and honest managers. We have been revisiting our discounted cash flow models to ensure that they reflect the economic scenarios that many of these businesses may face (e.g., the potential for higher and more sustained labour costs or inventory levels). We're speaking with management teams to understand how they're planning to tackle a potentially more challenging environment (e.g., if they are planning on reducing spending to protect their margins, are they cutting the fat or the bone).

Yet, while the odds of a soft landing may appear increasingly long, it is not a foregone conclusion. And regardless of how the economic outlook may evolve, we take comfort in the notion that over the long-term, stock prices tend to follow wealth-creation. As such, we continue to lean heavily into our philosophy and process in an effort to responsibly steward our clients' investments through uncertainty.

Related Party Transactions – Management Fees

The Portfolio Advisor receives management fees, which are calculated for Series A units as 1.50% per annum of the net asset value of the Fund calculated on a daily basis. Management fees for Series O units are payable directly to the Manager by Series O investors and not by the Fund.

Mawer Global Small Cap Fund

The terms of the Management Agreement were amended January 4, 1994, to grant the Manager of the Fund the ability, at their discretion, to reduce the management fees for large investors. This reduction is effected by means of a management fee distribution and will be automatically reinvested in additional units of the Fund at the net asset value of the Fund on the date of distribution. Mawer also receives fees for performing administrative services. As at June 30, 2022 the Fund owes Mawer \$0 related to these administrative services.

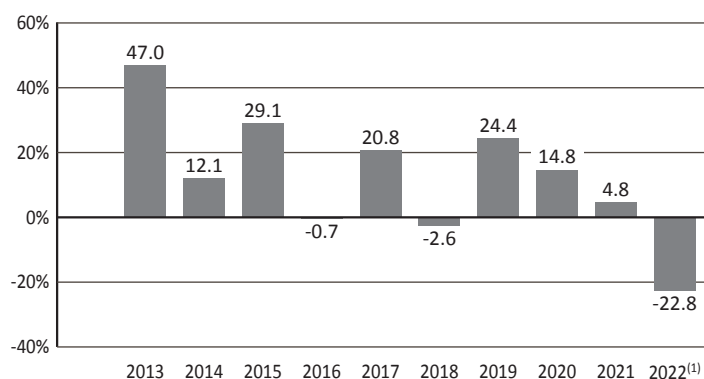
The Fund's performance numbers assume that all distributions are reinvested in additional units of the Fund. 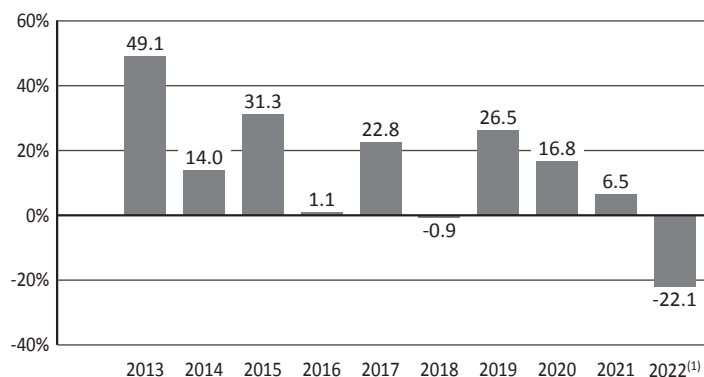
Year-by-Year Returns

Annual Compound Returns

The following table shows the historical annual compound total return of the Fund for the periods shown ending on June 30, 2022. The annual compound total return is benchmarked to the Mawer Global Small Cap Benchmark (GSC Benchmark) and calculated on the same compound basis. The GSC Benchmark is a composite return stream consisting of Russell Global Small Cap Index from inception to September 30, 2016 and the MSCI ACWI Small Cap Index (net), as of September 30, 2016. The MSCI ACWI Small Cap Index (net) captures small cap representation across 23 Developed Markets (DM) and 26 Emerging Markets (EM) countries. All index returns are calculated in Canadian dollars on a total return basis, meaning that all distributions are reinvested.
