### Management Discussion of Fund Performance

#### Investment Objectives and Strategies

The objective of the Mawer International Equity Fund (the "Fund") is to create a portfolio of non-North American equities that is diversified by both geography and industry. This is done by choosing companies that we believe will be wealth-creating in the long term and are trading at a discount to their intrinsic value. We prefer companies with enduring competitive advantages that will allow them to earn a return greater than their cost of capital over the long term. The Fund has a long-term buy and hold strategy and seeks to keep turnover low.

#### Risk

This Fund is suitable for investors seeking long-term growth and who have a medium tolerance for risk. General risks of investing in this Fund are outlined in the Prospectus and include the possibility of reduction in value of any given investment, liquidity risk, interest rate risk and currency risk amongst others.

The Manager attempts to reduce the exposure to these risks by not concentrating more than 20% of the net assets of the Fund in a particular Industry as defined by the Global Industry Classification Standards (GICS). It is also the Manager's policy to have no more than 10% of the net assets in any one common share of a corporation, at the time of purchase.

The Fund was invested in 8 of the 11 Global Industry Classification Standards (GICS) sectors as of June 30, 2022. The Fund's largest sector weightings were in Industrials (27%), Financials (24%), and Health Care (13%). Combined, the weight in the three largest sectors represented 64% of the portfolio, same as the 64% at the end of 2021. In aggregate, the ten largest individual holdings accounted for 36% of the portfolio, same as the 36% at the end of 2021.

#### Results of Operations

The Fund's net assets decreased 25.1% to \$6,678.2 million from \$8,918.7 million at June 30, 2022. Of this change, -\$2,180.0 million is attributable to investment performance and -\$60.5 million was due to net redemptions to the Fund.

The Manager assesses the fund's underlying securities for liquidity on a quarterly basis. During the period the fund has remained in compliance with National Instrument 81-102 and has maintained an illiquid concentration of less than 10% of the funds Net Asset Value. During the period there were no notable redemptions to the fund that affected its liquidity.

Year-to-date, the Fund's A series returned -24.9% (after management fees) in comparison to the MSCI ACWI ex USA (Net) return of -16.7%. All performance values provided are in Canadian dollar terms.

The Fund's relative performance was largely impacted by the negative security selection for the period, particularly in Financials, Industrials and Consumer Staples.

From a geographic perspective as well, security selection was negative, as the Fund's holdings were negatively impacted in the Europe and the Asia Pacific. Regional allocation was also negative over the period.

Overall, the top contributors to the Fund's performance year-to-date were Novo Nordisk A/S, Deutsche Boerse AG, and AstraZeneca PLC. Meanwhile, Taiwan Semiconductor Manufacturing Co., Ltd., AutoStore Holdings Ltd., and Ashtead Group plc, were the biggest year-to-date detractors.

The Fund also eliminated the position in JD.com which was received as a dividend from portfolio holding Tencent. Meanwhile, the Fund received the shares of China Conch Environmental following the spin-off from our fund holding China Conch Venture Holdings.

### Recent Developments

As the performance of various asset classes so far this year suggests, risks are clear and present: inflation, central bank tightening, and the withdrawal of accommodative monetary policy; war and its knock-on impacts to globalization and various commodity markets; and economic growth headwinds tied to COVID-19 shocks and the impact of rising food and energy prices on consumers. Margin pressures due to rising wage and input costs are beginning to impact corporate profits and we've seen severe reactions to earnings disappointments, particularly with respect to future guidance. The European economic outlook looks particularly grim given the increasing risk of a Russian gas embargo to the European Union. The recent performance of equities, credit spreads, economically-linked commodities such as copper, and the U.S. dollar all point to an increasingly pessimistic outlook.

Whereas the risks may appear heavily one-sided, we have been focused on ensuring that our emotions stay balanced. Our philosophy and process orient us toward businesses that are enduring, that have the ability to exercise pricing power through the value propositions they provide to their customers, and that are run by able and honest managers. We have been revisiting our discounted cash flow models to ensure that they reflect the economic scenarios that many of these businesses may face.

Yet, while the odds of a soft landing may appear increasingly long, it is not a foregone conclusion. And regardless of how the economic outlook may evolve, we take comfort in the notion that over the long-term, stock prices tend to follow wealth-creation. As such, we continue to lean heavily into our philosophy and process in an effort to responsibly steward our clients' investments through uncertainty.

On February 24, 2022, Russia launched a military invasion of Ukraine. Following economic sanctions imposed on Russian corporate and banking entities, closures to Russian securities markets, and Russian government-imposed capital controls, the liquidity of Russian securities and its currency has experienced significant declines. The Mawer International Equity Fund has direct exposure to a single Russian security (TCS Group Holding PLC GDR), this was written down, and continues to be held at a nil market value as a direct result of the inability to trade it. The Manager is actively monitoring the situation.

### Related Party Transactions – Management Fees

The Portfolio Advisor receives management fees, which are calculated for Series A units as 1.20% per annum of the net asset value of the Fund calculated on a daily basis. Management fees for Series O and Series S units are payable directly to the Manager by Series O and Series S investors and not by the Fund.

The terms of the Management Agreement were amended January 4, 1994, to grant the Manager of the Fund the ability, at their discretion, to reduce the management fees for large investors. This reduction is effected by means of a management fee distribution and will be automatically reinvested in additional units of the Fund at the net asset value of the Fund on the date of distribution. Mawer also receives fees for performing administrative services. As at June 30, 2022 the Fund owes Mawer \$0 related to these administrative services.

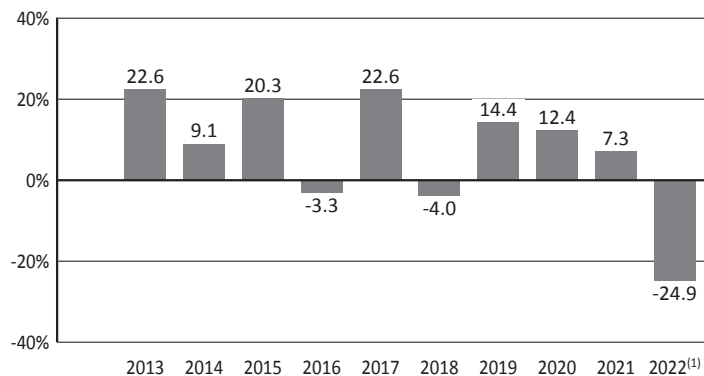

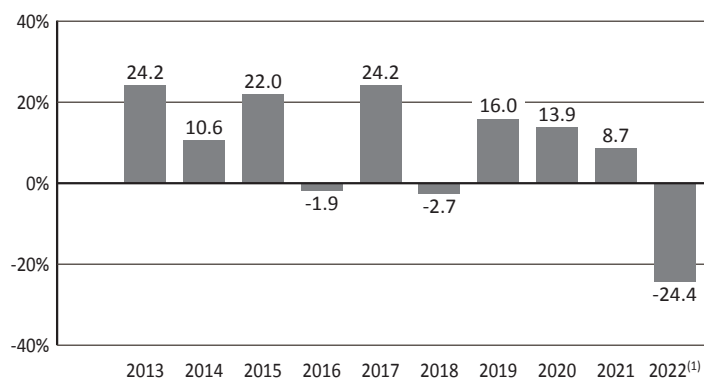
### Year-by-Year Returns

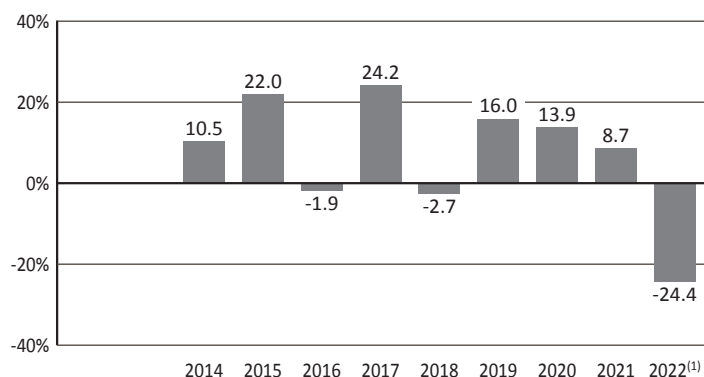
#### Series A

### Annual Compound Returns

The following table shows the historical annual compound total return of the Fund for the periods ending on June 30, 2022. The annual compound total return is benchmarked to the Mawer International Equity Benchmark (IE Benchmark) and calculated on the same compound basis. The IE Benchmark is a composite return stream consisting of the MSCI EAFE Index (net) from inception to September 30, 2016 and the MSCI ACWI ex-USA Index (net), as of September 30, 2016. The MSCI ACWI ex-USA Index (net) represents large and mid-cap stocks across 22 of 23 Developed Markets countries (excluding the U.S.) and 26 Emerging Market countries. All index returns are calculated in Canadian dollars on a total return basis, meaning that all distributions are reinvested.
