Investors seeking long-term, above average growth who can tolerate equity volatility. Medium to high risk.

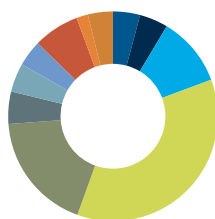
Investment Strategy

The Morningstar Rating, commonly referred to as the Star Rating, relates how a fund has performed on a risk-adjusted basis against its Morningstar category peers and is subject to change every month.
