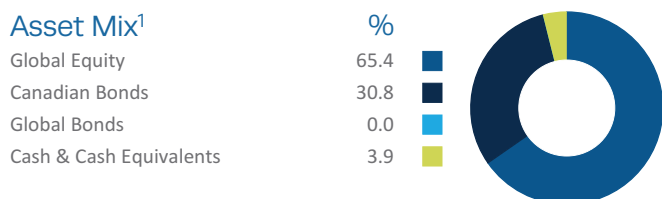

## Investment Strategy

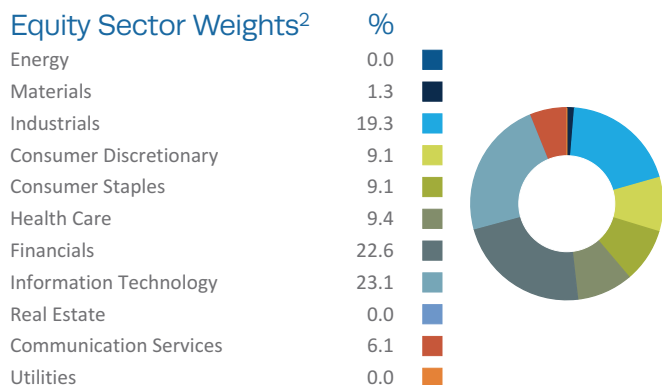
