Investment Strategy

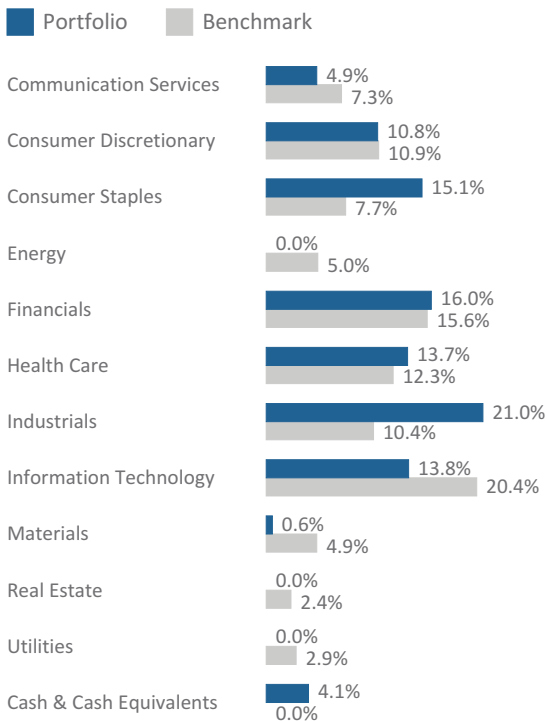

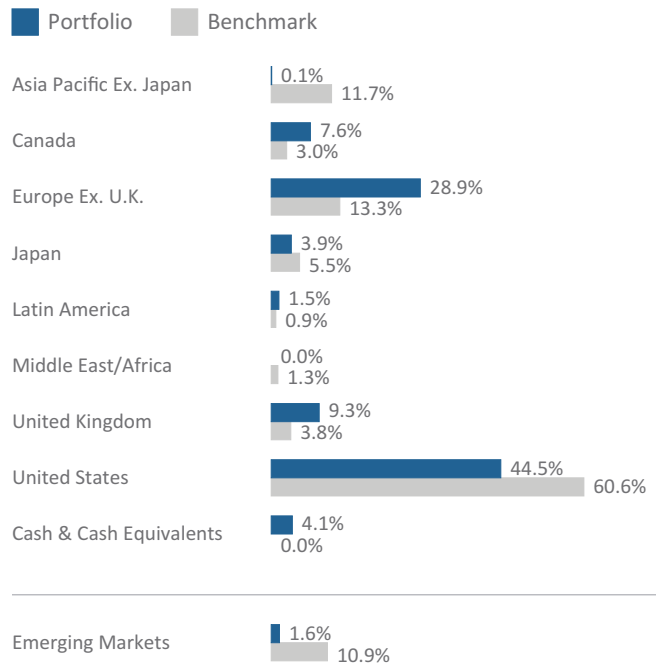
