Investment Strategy

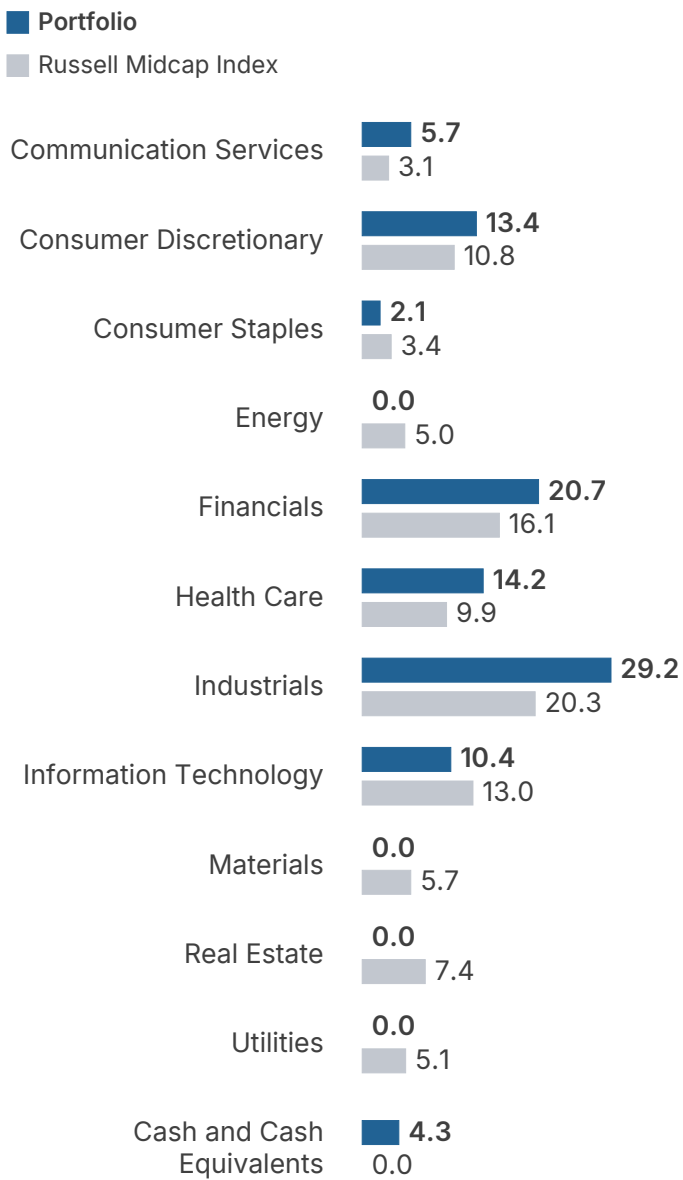
