## Investment Strategy

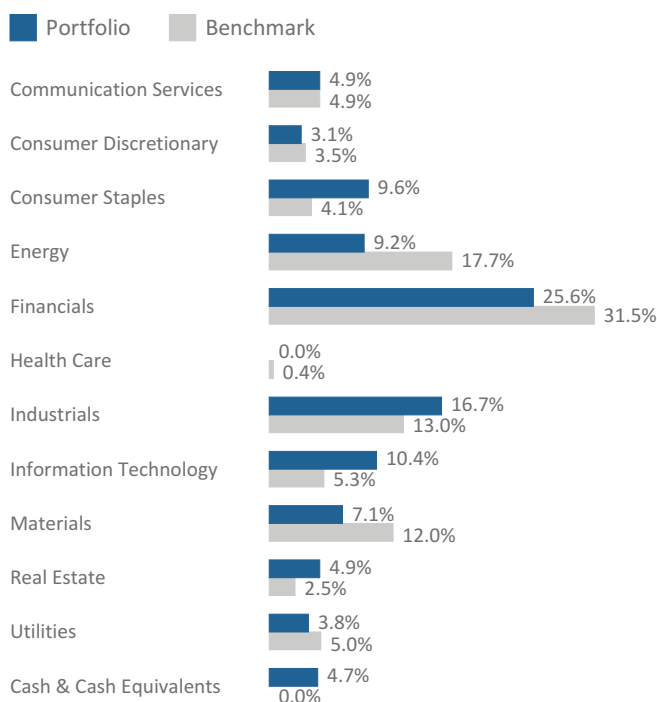
