## Investment Strategy

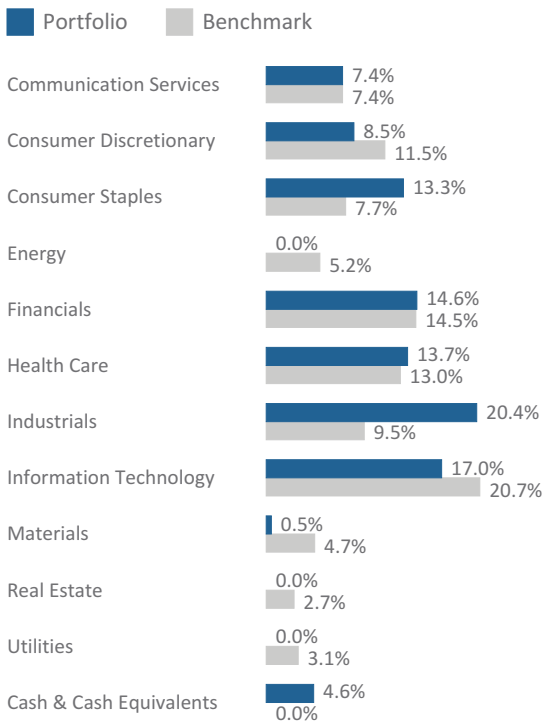

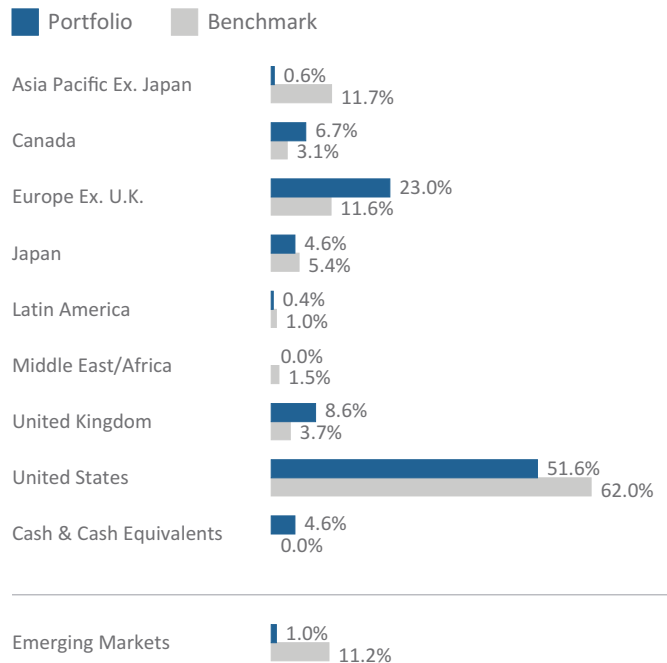
