Investment Strategy

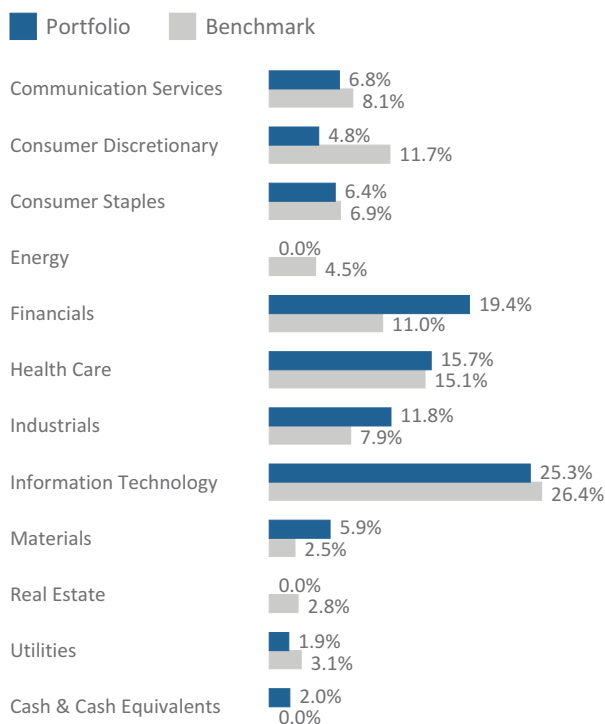
