## Mawer Investment Management Ltd. Announces Organizational Updates

### Paul Moroz, CFA, appointed Chief Investment Officer

Effective March 31, 2018, Paul Moroz, CFA, will assume the role of Chief Investment Officer for the firm. Jim Hall, CFA, who has held the CIO responsibilities since 2004, will continue as Chairman of the Board of Directors and as co-manager of the Canadian Equity and Global Equity strategies.

Since joining the firm in 2004, Mr. Moroz has worked closely with Mr. Hall and has been the Deputy CIO since 2012. In addition to his role as CIO, Mr. Moroz will remain co-manager of the Global Small Cap strategy and lead manager of the Global Equity strategy. He will also continue to sit on the firm's Board of Directors. In his 14 years at the firm, Mr. Moroz has held multiple roles including Equity Analyst, lead manager on the Global Small Cap strategy, and CEO of Mawer Investment Management Singapore Pte. Ltd. Prior to joining Mawer, Mr. Moroz held positions at Alberta Investment Management Corp. and Merrill Lynch Canada Inc.

### Christian Deckart, CFA, PhD., appointed Deputy Chief Investment Officer

Effective March 31, 2018, Christian Deckart, CFA, PhD., will assume the role of Deputy Chief Investment Officer for the firm and continue his role as lead-manager of the Global Small Cap strategy and co-manager of the Global Equity strategy. Mr. Deckart joined Mawer in 2013, was appointed co-manager of the Global Small Cap strategy in 2015, co-manager of the Global Equity strategy in 2016, and lead manager of the Global Small Cap strategy in 2018. Mr. Deckart began his career in 1997, holding positions at Bankhaus Reuschel & Co., Merrill Lynch, and, prior to joining Mawer, was a Portfolio Manager for a European Family Office in Zurich, Switzerland.

### Michael Mezei to retire as President at the end of 2018

After ten years as President of the firm, Michael Mezei plans to retire from Mawer Investment Management. Mr. Mezei will remain in his role as President until a successor is in place, likely by the end of 2018, and will continue serving on the firm's Board of Directors at least until the end of 2019. A succession committee is in place to guide the selection process for the new President and a precise retirement date and successor will be shared once plans have been solidified.
